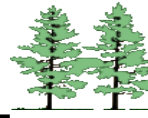

WATER SYSTEM IMPROVEMENT PROJECT

RECOMMENDATION

Adopt Resolution No. 26-XX authorizing the General Manager to execute the Construction Agreement with McGuire & Hester for the River Pines Public Utility District Water System Improvement Project (DWSRF Project No. 0310006-002C) in the amount of \$7,847,195, subject to final review and approval as to form by District Counsel and receipt of all required bonds, insurance, and contract documents.

BACKGROUND

The District completed a competitive bidding process for the Water System Improvement Project. The proposed agreement provides for construction of water system improvements by McGuire & Hester. The agreement includes a 600-calendar-day construction period following issuance of the Notice to Proceed, a two-year warranty, prevailing wage compliance, performance and payment bonds, insurance, certified payroll, and all applicable Drinking Water State Revolving Fund (DWSRF) requirements. The total contract amount, including Additive Alternates 1 and 2, is \$7,847,195.

CEQA

This action is not a separate project under the California Environmental Quality Act (CEQA). The Board's approval of the Construction Agreement implements the previously approved Water System Improvement Project for which CEQA review has already been completed. Approval of the agreement is an administrative action to carry out the approved project and does not constitute a separate discretionary approval requiring additional environmental review.

FISCAL IMPACT

Contract Amount: \$7,847,195.

Funding Source: Drinking Water State Revolving Fund (DWSRF) financing and other Board-approved project funding.

A RESOLUTION OF THE BOARD OF DIRECTORS OF THE RIVER PINES PUBLIC UTILITY DISTRICT AUTHORIZING THE GENERAL MANAGER TO EXECUTE THE CONSTRUCTION AGREEMENT FOR THE WATER SYSTEM IMPROVEMENT PROJECT

WHEREAS, the District completed a competitive procurement process for the River Pines Public Utility District Water System Improvement Project, DWSRF Project No. 0310006-002C; and

WHEREAS, McGuire & Hester was determined to be the responsive and responsible bidder and a Construction Agreement has been prepared in the amount of \$7,847,195; and

WHEREAS, the Project has previously satisfied the applicable requirements of the California Environmental Quality Act (CEQA), and execution of the Construction Agreement is an administrative action implementing the approved Project; and

NOW, THEREFORE, BE IT RESOLVED that the Board of Directors:

1. Approves the Construction Agreement with McGuire & Hester in the amount of \$7,847,195.
2. Authorizes the General Manager to execute the Agreement following approval as to form by District Counsel and confirmation that all required bonds, insurance, and contract documents have been received.
3. Authorizes the General Manager to administer the Agreement and execute routine construction administration documents consistent with the Agreement and Board-approved budget. Any amendment increasing the contract amount or materially changing the scope shall require Board approval.

AGREEMENT FOR THE COMPLETION OF RIVER PINES PUBLIC UTILITY DISTRICT
WATER SYSTEM IMPROVEMENT PROJECT

THIS AGREEMENT made and entered into this _____ day of July, 2026, by and between **MCGUIRE & HESTER**, hereinafter referred to as "Contractor", and the **RIVER PINES PUBLIC UTILITY DISTRICT**, a political subdivision of the State of California hereinafter referred to as "District".

W I T N E S S E T H

THAT THE PARTIES HERETO have mutually covenanted and agreed, and by these presents do covenant and agree with each other as follows:

Section 1. The Work:

River Pines Public Utility District Water System Improvement Project,
DWSRF Project No. 0310006-002C.

Section 1 (a) The Scope:

Contractor is to furnish all labor, materials, equipment, transportation, site work, and services for the completion of the **River Pines Public Utility District Water System Improvement Project, DWSRF Project No. 0310006-002C.**

Section 1 (b) The Guarantee:

- A. Should any of the materials installed pursuant to the Plans, Specifications and Contract Documents, except existing materials or materials furnished by the District prove defective or should any of the work prove defective due to faulty workmanship, materials furnished or methods of construction within two years from the date of acceptance of the work by the District, the Contractor shall reimburse the District, upon demand, for its expenses included in restoring the work to the condition contemplated in said Plans, Specifications and Contract Documents, including the cost of any materials and repair the work completely without cost to the District.
- B. During the guarantee period, the District shall have the unqualified option to make any needed repairs or replacements done by the Contractor. In the event the District elects to have said work performed by the Contractor, the Contractor shall furnish all necessary materials and make the required repairs and installations within a reasonable time after receipt of notice from the District. The District will give notice of observed defects with reasonable promptness.

Section 2. Time:

Contractor shall begin work within fifteen (15) calendar days from the Notice to Proceed. The date of the Notice to Proceed shall be the first day of work. The work shall be completed within 600 (six hundred) calendar days from the date of the Notice to Proceed.

Section 3. The Contract Documents.

The Construction Contract consists of the following documents:

Invitation to Bid, Accepted Bid; Payment Bond; Faithful Performance Bond; the Plans and Specifications for the project; Attachments A and B; and Addendum No. 1, 2, 3 & 4 issued prior to the bid opening date; and this Construction Agreement ("Agreement").

The Plans and Specifications and all Attachments herein referred to are intended to cooperate so that anything exhibited in the Plans not mentioned in the Specifications, or vice versa, is to be executed the same as if both are mentioned in the Specifications and set forth in the Plans, to the true intent and meaning of the said Plans and Specifications when taken together; and differences of opinion respecting the same shall be finally determined by the District.

Section 4. Changes:

The Work under this contract shall not be changed except by prior order of the District; and any such change shall be specified in writing in advance and the cost thereof agreed upon between the parties; and in no case shall the District pay or become liable to pay for any extra work done on, or extra material furnished for, in or about said work, except as otherwise provided in the Plans and Specifications; said Plans and Specifications shall control in all particulars

Section 5. Instructions to Bidders:

The Instructions to Bidders heretofore given by the District for this Work and accepted bid submitted therefore by the Contractor are hereby referred to and made a part of this agreement.

Section 6. Liquidated Damages:

If the Contractor fails to complete this agreement and this Work within the time fixed for completion, due allowance being made for the contingencies provided for herein, the Contractor becomes liable to the District for all loss and damage which the latter may suffer on account thereof; and it is agreed that it is and will be impracticable and extremely difficult to ascertain and determine the actual damage which the District will sustain by reason of any delay in performance of this agreement; and it is therefore agreed that said Contractor will pay as liquidated damages to the District the sum of \$1,000.00 per day for each working day's delay beyond the time herein prescribed for finishing the Work; and in case the sum be not paid, the District may deduct the

amount thereof from any money due or that may become due the Contractor under this agreement in addition to any other remedy that is available to the District.

Section 7.

Termination or Breach.

If the Contractor should be adjudged bankrupt or if it should make a general assignment for the benefit of its creditors, or if a receiver should be appointed on account of its insolvency, or if it or any of its subcontractors should violate any of the provisions of the Agreement, or for nonperformance or poor performance by the Contractor, the District may serve written notice upon it of its intention to terminate the Agreement. Such notice shall contain the reasons for such intention to terminate the Agreement and, unless within ten (10) calendar days after serving of such notice, such violation shall cease and arrangement satisfactory to District for correction thereof be made, the Agreement shall, upon the expiration of said ten (10) calendar days, cease and terminate. In the event of any such termination, the District shall immediately serve written notice thereof upon the Contractor. The District may take over the Work and prosecute the same to completion by contract or any other method it may deem advisable, for the account and at the expense of the Contractor, and the Contractor and its surety shall be liable to the District for any excess cost occasioned the District thereby, and in such event the District may without liability for so doing take possession of and utilize in completing the Work, such materials, appliances, plant, and other property belonging to the Contractor as may be on the site of the Work and necessary thereof.

Notwithstanding the above, the District retains the right to terminate this Agreement without cause by providing the Contractor with Notice in Writing. The Agreement shall be terminated twenty (20) calendar days after notice is sent by the District to the Contractor. If the District exercises the right to terminate the Agreement without cause, the District shall pay the Contractor the portion of the total contract amount which reflects the percentage of work completed by the Contractor through the effective date of the termination

Section 8. Indemnity:

To the fullest extent permitted by law, the Contractor shall hold the District and the State Water Resources Control Board (State Water Board), its agents, officers, employees, officials, servants and volunteers, harmless from, save, defend and indemnify the same against, any and all claims (including, without limitation, claims for bodily injury or death), losses, demands, suits, judgments, fines, penalties, and damages for every cause, including but not limited to injury to a person or property, and related costs and expenses, including reasonable attorney's fees and court costs, arising directly or indirectly out of any act or omission of Contractor, its agents, officers, employees, guests, invitees, or volunteers, during the performance of its obligations under this Agreement or arising out of the failure on Contractor's part to perform its obligations under this Agreement.

Section 9. Public Liability and Property Damage Insurance:

The Contractor, and all subcontractors, consultants, and other agents hired by Contractor (unless otherwise specified below), shall provide at its own expense and maintain at all times the following insurance with insurance companies licensed in the State of California and shall provide evidence of such insurance to the District as may be required. The policies or certificates thereof shall provide that thirty (30) calendar days prior to cancellation or material change in the policy, notices of same shall be received by the Secretary of the District by registered mail, return receipt requested, for all of the following stated insurance policies.

A. Worker's Compensation - in compliance with the statutes of the State of California, with statutory limits as required by the Labor Code of the State of California for all employees employed at the site of improvement, unless excluded from Worker's Compensation Insurance requirements, and in case any work is sublet, Contractor shall require any contractors' or subcontractors' employees, unless such employees are covered by the protection afforded by Contractor. Contractor hereby indemnifies District for any damage resulting to it from failure of either Contractor or any contractor or subcontractor to take out or maintain such insurance.

The workers' compensation policy is to be endorsed with a written waiver of the insurer's right to subrogate against the River Pines Public Utility District. The insurance company, in its endorsement, agrees to waive all rights of subrogation against the District, its officers, officials, employees and volunteers for losses paid under the terms of this policy which arise from the work performed by the named insured for the District.

In addition, Contractor shall maintain Employer's Liability Insurance with limits of \$1,000,000 per Accident, \$1,000,000 Disease per employee, \$1,000,000 Disease per policy.

Satisfactory evidence of coverage is required, including:

- Subrogation waiver endorsement; and
- Properly completed Certificate of Insurance

B. General Liability: Commercial General Liability Insurance coverage no less broad than ISO form CG 00 01.

i. Coverage must be on a standard Occurrence form. Claims-made forms are not acceptable without prior written consent. Modified, limited or restricted Occurrence forms are not acceptable without prior written consent.

ii. Minimum Limits for General Contractor:

\$2,000,000 – Each Occurrence

\$4,000,000 – General Aggregate

\$4,000,000 – Products/Completed Operations Aggregate. The General Aggregate shall apply separately to each Project.

iii. Minimum limits for other contractors and subcontractors:

\$1,000,000 – Each Occurrence

\$2,000,000 – General Aggregate. The General Aggregate shall apply separately to each Project. If contractors maintain higher limits than the specified minimum limits, District requires and shall be entitled to coverage for the higher limits maintained by contractors.

iv. Prior written consent is required if the insurance has a deductible or self-insured retention in excess of \$50,000.

v. Coverage shall be continued for two (2) years after completion of the work.

vi. The River Pines Public Utility District and State Water Board must be additional insured for liability arising out of ongoing and completed operations by or on behalf of the Contractor and such coverage shall continue for two (2) years after completion of the work.

vii. The policy definition of “insured contract” must include assumptions of liability arising out of both ongoing operations and the products-completed operations hazard (“F” definition on insured contract in ISO form CG 00 01, or equivalent).

viii. The insurance provided to the River Pines Public Utility District and State Water Board as additional insured must apply on a primary and non-contributory basis with respect to any insurance or self-insurance program maintained by the River Pines Public Utility District or State Water Board.

ix. Thirty (30) days prior written notice of cancellation or material change must be provided to the River Pines Public Utility District.

x. The policy must cover inter-insured suits and include a “separation of insureds” or severability clause which treats each insured separately.

xi. The policy shall not contain a Contractors’ Warranty or other similar language which eliminates or restricts insurance because of a subcontractor’s failure to carry specific insurance or to supply evidence of such insurance.

xii. Satisfactory evidence of coverage is required including:

- Copy of the additional insured endorsement or policy language granting additional insured status;
- Copy of the endorsement or policy language indicating that coverage applicable to the River Pines Public Utility District is primary and non-contributory; and
- Properly completed Certificate of Insurance) Commercial General Liability Insurance coverage no less broad than ISO form CG 00 01

C. Automobile Liability insurance with minimum limit of liability per occurrence of \$1,000,000 for bodily injury and property damage. This insurance shall cover for bodily injury and property damage, owned vehicles, non-owned automobiles, and hired vehicles. River Pines Public Utility District and State Water Board must qualify as an insured.

D. Pollution Liability.

i. Minimum Limits: \$1,000,000 per Pollution incident; \$2,000,000 Aggregate;

ii. Coverage must apply to pollution incidents at or from any location at which Contractor is performing work under this Agreement;

iii. Prior written consent is required if the insurance has a deductible or self-insured retention in excess of \$50,000;

- iv. If the insurance is on a Claims-Made basis, the retroactive date shall be no later than the commencement of work;
- v. The insurance must be continued two (2) years after completion of the Work. If the insurance is on a Claims-Made basis, the continuation coverage may be provided by:
- vi. Renewal of the existing policy; or, an extended reporting period endorsement; or Replacement insurance with a retroactive date no later than the commencement of the Work;
- vii. Thirty(30) days prior written notice of cancellation or material change must be provided to the River Pines Public Utility District;
- viii. Satisfactory evidence of coverage is required including:
 - Copy of claim reporting procedures if policy is on a Claims-Made basis; and
 - Properly completed Certificate of Insurance

E. Insurance Documentation. In addition to the specific evidence of coverage requirements listed above, the following satisfactory documentation of insurance requirements is required;

- i. Insurance policies must be issued by an insurer with an A.M. Best's rating of at least A:VII.
- ii. Upon written request by District, certified copies of required insurance policies shall be provided within 30 days.
- iii. All references to the River Pines Public Utility District for insurance coverage shall mean the River Pines Public Utility District, its elected and appointed board, commissions, officers, agents, employees, servants and volunteers shall be so described on required certificates.
- iv. All references to the State Water Resources Control Board for insurance coverage shall mean the State Water Resources Control Board, its officers, agents, employees and servants shall be so described on required certificates.
- v. The project name, agreement number and address of the River Pines Public Utility District must be shown on the Certificate of Insurance, the Additional Insurance Endorsement(s) and Notice of Cancellation, i.e., River Pines Public Utility District, 22900 Canyon Avenue, P.O. Box 70, River Pines, CA 95675.
- vi Current Evidence of Coverage must be provided for the entire required period of insurance.

NOTE: Contractor agrees and stipulates that any insurance coverage provided to the River Pines Utility District shall provide for a claims period following termination of coverage which is at least consistent with the claims period or statutes of limitations found in the California Government Claims Act (California Government Code Section 810 et seq.).

Section 10. Labor Code:

Both parties recognize the applicability of various laws, especially Chapter 1 of Part 7 of the California Labor Code (beginning with Section 1720), and intend that this agreement complies therewith. The parties specifically agree that the relevant penalties and forfeitures provided in the

Labor Code, especially in Sections 1775, 1815 and 1853, concerning wages, hours, shall apply to this agreement as though fully stipulated herein.

Section 11. Prevailing Wage Rates and Apprenticeships:

Employees of the Contractor and all subcontractors engaged on this project shall be compensated at or above the current prevailing wage rate determination issued by the Department of Industrial Relations. Copies of the applicable current **State and Federal prevailing wage rates** are included in Attachment B. The contractor shall **pay the higher wage rate** in each craft, classification or worker type. Those prevailing wages are hereby incorporated in this agreement and made a part hereof. A copy of the applicable current prevailing wage rates shall be posted at the job site.

Compliance with Section 1777.5 of the Labor Code, dealing with the employment of properly registered apprentices in all applicable occupations involved in the construction of this project, shall remain the responsibility of the Contractor. ***No apprentice may be placed on the job without prior submission of apprenticeship registration, allowable pay rates and approval of District's Representative. Failure to obtain prior approval will require payment of journeyman wages until approval is received.***

Section 12. Hours of Labor:

Eight hours of labor constitutes a legal day's work, and no workman employed at any time by the Contractor, or by any subcontractor, upon the work or upon any part of the work under this contract shall be required or permitted to work thereon more than eight hours in any one calendar day except as provided in Labor Code Sections 1810 and 1817, inclusive.

Section 13. Price:

In consideration of the covenants, promises and agreements on the part of the Contractor, and their strict and literal fulfillment, and as full compensation agreed upon for said work and construction, installation, and completion, the District agrees to pay the Contractor for the base bid and additive alternates 1 & 2 the sum of \$7,847,195.00 (seven million, eight hundred forty-seven thousand, one hundred ninety-five dollars) in legally executed warrants of the District in accordance with the schedule herein provided, upon certificates issued by the District or its agent.

Section 14. Payment:

On or about the first day of each calendar month the Contractor shall submit to the District applications for payment, supported by a statement detailing all materials actually installed during the preceding month, the labor expended thereon, and the cost thereof; whereupon, after verification, a certificate for the amount determined to be due, less five percent (5%) thereof, will be issued by the District to the Contractor.

No certificate will be issued until defective work and materials have been removed, replaced and made good.

The payment of progress payments by the District shall not be construed as an absolute acceptance of the work done up to the time of such payments.

Section 15. Payments Withheld:

Pursuant to Public Contracts Code Section 22300, the District or its agent may withhold or, on account of subsequently discovered evidence, nullify all or part of any certificate to such extent and period of time only as may be necessary to protect the District from loss on account of:

- a) Defective work not remedied.
- b) Claims filed or reasonable evidence indicating probable filing of claims.
- c) Failure of the Contractor to make payments properly to subcontractors or for material or labor.
- d) A reasonable doubt that the contract can be completed for the balance then unpaid.
- e) Damage of another Contractor.
- f) Failure to supply certified payrolls, backup documentation and labor standards certifications and other State and federal submittals as required by this contract.

Thirty-five calendar days after recording of the notice of completion of the entire work by the District or its agent, the District shall issue a certificate to the Contractor and pay the balance of the contract price, provided the Contractor shows that all claims for labor and materials have been paid, and no claims have been presented to the District based on acts or omissions of the Contractor, and no liens or withhold notices have been filed against the said work or site. The District or its agent shall use reasonable diligence to discover and report to the Contractor as the work progresses, the materials and labor which are not satisfactory so as to avoid unnecessary trouble or cost to the Contractor in making good defective work or parts.

Section 16. Subcontractors:

Prior to allowing any subcontractor to begin work on the job, Contractor must obtain written approval from the District. Contractor will submit name, license number, Department of Industrial Relations registration number, place of business, and service provided. Contractor will submit copies of all subcontracts, incorporating these contract documents by reference, within 10 days of execution. Contractor will also supply labor standards certifications and insurance certifications for all subcontractors with subcontracts.

It is understood that Public Contracts Code Sections 4100 through 4114 bind the parties, and by this reference they are deemed incorporated herein as set forth in full.

Section 17. Assignment:

This agreement binds the heirs, successors, assigns and representatives of the Contractor, but neither this agreement, nor any part thereof, nor any moneys due or to become due hereunder, may be assigned by the Contractor without the prior consent of the District and the Contractor's surety or sureties, unless they have waived notice of assignment.

Section 18. Bonds:

The Contractor shall deliver to the District for approval upon executing this contract good and sufficient bonds with sufficient sureties as follows:

- (1) In the sum of 100% of the contract price conditioned on the Contractor's faithful performance of this agreement according to its terms and conditions, and
- (2) A labor and materials payment bond for 100% of the contract price in accordance with Civil Code Section 3247.

Section 19 - Non-discrimination Clause:

During the performance of this Agreement, the Contractor and its subcontractors shall not unlawfully discriminate, harass or allow harassment, against any employee or applicant for employment because of sex, race, color, ancestry, religious creed, national origin, disability (including HIV and AIDS), medical condition (cancer), age, marital status, denial of family and medical care leave, and denial of pregnancy disability leave. Contractor and subcontractors shall ensure that the evaluation and treatment of their employees and applicants for employment are free from such discrimination and harassment. Contractor and subcontractors shall comply with the provisions of the Fair Employment and Housing Act (Government Code, Section 12900 et seq.) and the applicable regulations promulgated there under (California Code of Regulations, Title 2, Section 7285.0 et seq.). The applicable regulations for the Fair Employment and Housing Commission implementing Government Code, Section 12900 (a-f), set forth in Chapter 5 of Division 4 of Title 2 of the California Code of Regulations are incorporated into this Agreement by reference and made a part hereof as if set forth in full. Contractor and its subcontractors shall give written notice of their obligations under this clause to labor organizations with which they have a collective bargaining or other agreement.

Section 20 - Maintenance of Records:

In accordance with state and federal requirements, Contractor shall maintain all project records, and provide access to the District, the State of California, Department of Water Resources or their representatives. For six years from the filing of the Notice of Completion.

Section 21 -Certified Payrolls

All contractors will submit certified payrolls to the District's Representative within 7 days of the end of each weekly payroll period. Other Labor Standards requirements for this project are specified in Attachment B. Payment will not be released until certified payrolls and labor standards certifications are current and complete.

Section 22. Mandatory Pre-construction Conference:

Contractor, all subcontractors and their payroll officers will attend the mandatory pre-construction conference. Failure to attend will require that the meeting be rescheduled at the contractor's cost.

Section 23 - District's Right to Withhold Certain Amounts and Make Application Thereof

In addition to the amount which the District may retain under Section 14 of this Agreement until the final completion and acceptance of all work covered by the Agreement, the District may withhold from payment to the Contractor such an amount or amounts as in its exclusive judgment may be necessary to pay just claims against the Contractor or any subcontractors for labor claims against the Contractor or any subcontractors for labor and services rendered and materials furnished in or about the work. The District may apply such withheld amounts to the payment of such claims at its discretion. In so doing, the District shall be deemed the agent of Contractor and any payment so made by the District shall be considered as a payment made under the Agreement by the District to the Contractor and the District shall not be liable to the Contractor for any such payment made in good faith. Such payment may be made without prior judicial determination of the claim or claims.

Section 24. American Iron and Steel Requirement

This project is being funded with monies made available by the Drinking Water State Revolving Fund that have statutory requirements commonly known as "American Iron and Steel;" that requires all of the iron and steel products used in the project to be produced in the United States ("American Iron and Steel Requirement") including iron and steel products provided by the Contractor pursuant to this Agreement.  - 3. Keep all program records for at least six years after the contract and any and all amendments expire or six years after the completion and resolution of any audits or lawsuits, whichever is later.
 - 4. Allow the River Pines Public Utility District, State of California Department of Water Resources and other state or federal agencies to access all relevant records for grant monitoring or auditing purposes.
 - 5. Contractor will comply with all applicable requirements of Attachment B.

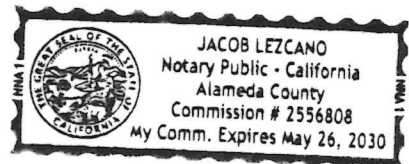

Note: Executive Order (EO) 13706, Establishing Paid Sick Leave for Federal Contractors applies to all contracts subject to the Davis-Bacon Act for which the contract is awarded (and any solicitation was issued) on or after January 1, 2017. If this contract is covered by the EO, the contractor must provide employees with 1 hour of paid sick leave for every 30 hours they work, up to 56 hours of paid sick leave each year. Employees must be permitted to use paid sick leave for their own illness, injury or other health-related needs, including preventive care; to assist a family member (or person who is like family to the employee) who is ill, injured, or has other health-related needs, including preventive care; or for reasons resulting from, or to assist a family member (or person who is like family to the employee) who is a victim of, domestic violence, sexual assault, or stalking. Unlisted classifications needed for work not included within the scope of the classifications listed may be added after award only as provided in the labor standards contract clauses (29CFR 5.5 (a) (1) (iii)).

The body of each wage determination lists the classifications and wage rates that have been found to be prevailing for the type(s) of construction and geographic area covered by the wage determination. The classifications are listed in alphabetical order under rate identifiers indicating whether the particular rate is a union rate (current union negotiated rate), a survey rate, a weighted union average rate, a state adopted rate, or a supplemental classification rate.

Union Rate Identifiers

A four-letter identifier beginning with characters other than ""SU"", ""UAVG"", ?SA?, or ?SC? denotes that a union rate was prevailing for that classification in the survey. Example: PLUM0198-005 07/01/2024. PLUM is an identifier of the union whose collectively bargained rate prevailed in the survey for this classification, which in this example would be Plumbers. 0198 indicates the local union number or district council number where applicable, i.e., Plumbers Local 0198. The next number, 005 in the example, is an internal number used in processing the wage determination. The date, 07/01/2024 in the example, is the effective date of the most current negotiated rate.

Union prevailing wage rates are updated to reflect all changes over time that are reported to WHD in the rates in the collective bargaining agreement (CBA) governing the classification.

Union Average Rate Identifiers

The UAVG identifier indicates that no single rate prevailed for those classifications, but that 100% of the data reported for the classifications reflected union rates. EXAMPLE: UAVG-OH-0010 01/01/2024. UAVG indicates that the rate is a weighted union average rate. OH indicates the State of Ohio. The next number, 0010 in the example, is an internal number used in producing the wage determination. The date, 01/01/2024 in the example, indicates the date the wage determination was updated to reflect the most current union average rate.

A UAVG rate will be updated once a year, usually in January, to reflect a weighted average of the current rates in the collective bargaining agreements on which the rate is based.

Survey Rate Identifiers

The ""SU"" identifier indicates that either a single non-union rate prevailed (as defined in 29 CFR 1.2) for this classification in the survey or that the rate was derived by computing a weighted average rate based on all the rates reported in the survey for that classification. As a weighted average rate includes all rates reported in the survey, it may include both union and non-union rates. Example: SUFL2022-007 6/27/2024. SU indicates the rate is a single non-union prevailing rate or a weighted average of survey data for that classification. FL indicates the State of Florida. 2022 is the year of the survey on which these classifications and rates are based. The next number, 007 in the example, is an internal number used in producing the wage determination. The date, 6/27/2024 in the example, indicates the survey completion date for the classifications and rates under that identifier.

?SU? wage rates typically remain in effect until a new survey is conducted. However, the Wage and Hour Division (WHD) has the discretion to update such rates under 29 CFR 1.6(c)(1).

State Adopted Rate Identifiers

The ""SA"" identifier indicates that the classifications and prevailing wage rates set by a state (or local) government were adopted under 29 C.F.R 1.3(g)-(h). Example: SAME2023-007 01/03/2024. SA reflects that the rates are state adopted. ME refers to the State of Maine. 2023 is the year during which the state completed the survey on which the listed classifications and rates are based. The next number, 007 in the example, is an internal number used in producing the wage determination. The date, 01/03/2024 in the example, reflects the date on which the classifications and rates under the ?SA? identifier took effect under state law in the state from which the rates were adopted.

WAGE DETERMINATION APPEALS PROCESS

1) Has there been an initial decision in the matter? This can be:

- a) a survey underlying a wage determination
- b) an existing published wage determination
- c) an initial WHD letter setting forth a position on a wage determination matter
- d) an initial conformance (additional classification and rate) determination
